1 AN ACT concerning

Vehicle Laws – Speed Monitoring Systems – Local Jurisdictions

- 3 FOR the purpose of requiring that a speed monitoring system calibration check be performed by an independent calibration laboratory that is unaffiliated with the 4 $\mathbf{5}$ manufacturer of the speed monitoring system; requiring a local jurisdiction to 6 use a speed monitoring system that meets certain model minimum performance 7specifications; requiring a local jurisdiction to keep certain documentation 8 related to speed monitoring systems and all recorded images on file and 9 available for inspection by the public; requiring a certificate alleging that a 10 certain speeding violation occurred to be sworn to or affirmed by a certain law 11 enforcement officer; requiring a court to issue a summons to appear to a speed monitoring system operator if requested in writing within a certain time by a 12person who received a citation based on a recorded image produced by a speed 13 14monitoring system; authorizing a person named in a citation based on a 15recorded image produced by a speed monitoring system to use the recorded 16 image in defense of the violation charged; prohibiting a contractor's fee from being contingent on the number of citations issued or paid if the contractor 17administers or processes the citations; and generally relating to speed 18 monitoring systems operated by local jurisdictions. 19
